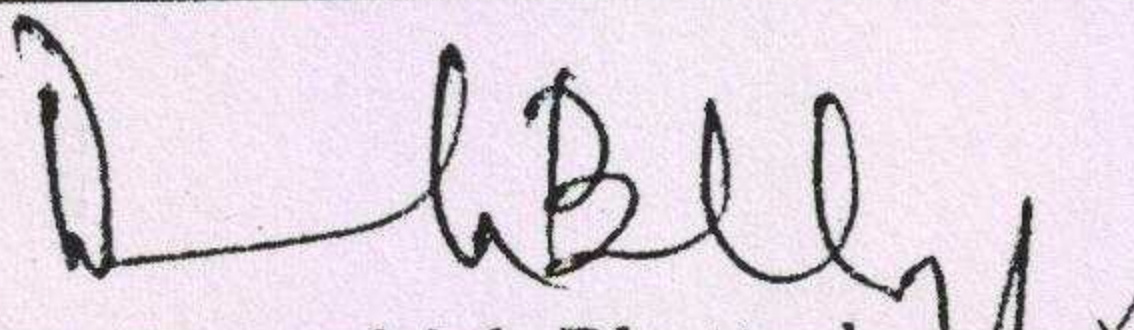
OFFICE MEMORANDUM

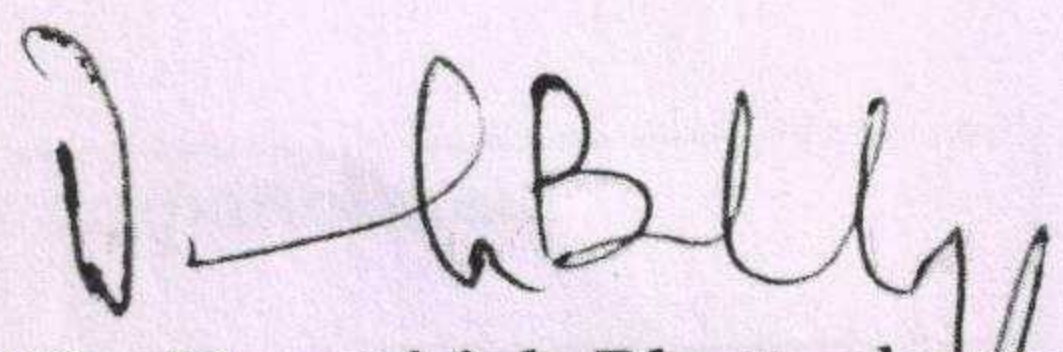
