OFFICE MEMORANDUM

Sub: Deadline for Extension of deadline for execution of Memorandum of Agreement (MoA) by existing empanelled Health Care Organizations (HCOs) under DGEHS-Regarding.

Reference: Office Memorandum No. F 25(III)/DGEHS/1310/DHS (HQ)/2020-21/6054-65 dated 30th March 2026 regarding extension of Empanelment of Private Health Care Organisations (HCOs) under DGEHS.

Vide the above mentioned Office Memorandum dated 30.03.2026 regarding extension of Empanelment of Private Health Care Organizations (HCOs) under DGEHS, the date for execution of MoA was 22.04.2026 and extension of the empanelment for existing hospitals was till 30.04.2026.

In continuation of this office Memorandum dated 30.03.2026 on the subject cited above, it is hereby informed that the Memorandum of Agreement (MoA) is to be executed with existing empanelled Health Care Organizations (HCOs) at the earliest.

In view of the above, and in continuation of Office Memorandum dated **30.03.2026**, the Competent Authority has approved the following:

- Extension of empanelment of existing empanelled HCOs under DGEHS (who have submitted their application on or before 30.04.2026) is being extended till 31.05.2026.
- Timeline for submission of documents for fresh empanelment by existing HCOs (as per SOP) was till 10.04.2026 but some HCOs have submitted their applications after the due date therefore, the date of considering their applications is **30.04.2026**.

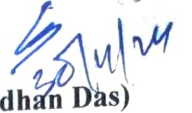

5. Consequence of Non-Compliance De-empanelment from DGEHS: It is hereby notified for STRICT COMPLIANCE that all currently empanelled HCOs that fail to submit the fresh application as per above stipulation shall be considered de-empanelled from DGEHS with effect from 1st May 2026. Such HCOs shall not be eligible to treat DGEHS beneficiaries under DGEHS rates, and no claims in respect of treatments rendered after the date of de-empanelment shall be entertained. However, the DGEHS beneficiaries already admitted in the HCOs for treatment prior to the issue of this order shall continue to be provided treatment at DGEHS rates

till their discharge. Re-empanelment in such cases shall be subject to the applicable fresh empanelment process, at the sole discretion of the competent authority.
