ORDER

It has come to the notice of this Directorate that some empanelled hospitals are charging pensioner beneficiaries for certain consumables like foley's catheter, gloves etc. while providing treatment to Delhi Government Employees Health Scheme (DGEHS) beneficiaries which is against the provisions of the DGEHS scheme.

As per provision of DGEHS scheme, some beneficiaries including pensioners are entitled for cashless treatment in DGEHS empanelled private hospitals. The cashless facility is not only limited to IPD treatment but also include OPD/Emergency treatment and minor procedures like foley's catheterization, dressing etc.

Therefore, all empanelled private hospitals/centres are, hereby, directed to provide cashless treatment to the beneficiaries entitled for cashless facility as per provision of the DGEHS scheme. The DGEHS beneficiaries entitled for cashless facility should not be charged for any items/consumables which are essential for OPD/IPD/ Emergency treatment/procedure.
