CIRCULAR

Sub:-De-empanelment of Health Care Organizations (HCOs) under DGEHS.

This circular is issued to inform all stakeholders that the Central Government Health Scheme (CGHS) has removed/de-empanelled the healthcare organizations listed below. As these organizations were initially empanelled under the DGEHS based on their status with the CGHS, their empanelment under the DGEHS is now automatically terminated. This action is taken in accordance with Clause 20(b), which stipulates:

"Empanelment under DGEHS shall stand automatically terminated whenever the empanelment of a hospital/diagnostic centre is terminated by the CGHS for any reason."

The termination is effective from the date of their de-empanelment from the CGHS.
