OFFICE MEMORANDUM

Keeping in view difficulties being faced by the DGEHS pensioners beneficiary in obtaining permission of knee and hip surgery & implant used from this Directorate it has been decided by the Director General of Health Services, GNCTD that henceforth prior permission of this Directorate for knee and hip implants in case the patient is suffering from osteoarthritis, decompression, fracture, cancer/tumour disease is not required.

Further, the rates for the knee and hip surgery shall be charged as per ceiling rates of DGEHS/CGHS. The implants category wise as notified vide OM No. 25(III)/DGEHS/Misc./509/DHS/2016-17/Part-I/239452-617 dated 15-01-2018 (copy attached). The sticker, outer pouch, original invoice, etc. of the implant and treatment related documents to reach the conclusion of surgery shall be attached with the bill while claiming the reimbursement from this Directorate.
