In continuation to this office order dated 24-04-2020 of even no. wherein CGHS approved rates for COVID - 19 test were adopted under DGEHS, it is informed that Govt. of NCT of Delhi has fixed the rates for COVID-RT PCR test at Rs. 2400/- per test inclusive of GST/Taxes, if any, cost involved in picking & transportation of samples, documentation and reporting w.e.f 18-06-2020 vide Order No. 52/DGHS/PH-IV/COVID-19/2020/prsecyhfw/14143-182 dated 18-06-2020.

In view of above all DGEHS empanelled Hospitals/Diagnostic centres, authorized by ICMR for COVID-RT PCR testing, are directed to raise bills for COVID-RT PCR test as per rates fixed by Govt. of NCT of Delhi, in case of DGEHS beneficiaries.

It has been brought to the cognizance of the undersigned that some of the empanelled hospitals are forcing the DGEHS pensioners beneficiaries to pay for the COVID-RT PCR test in cash. This is a violation of DGEHS agreement and action as deemed fit will be taken against such hospital/Diagnostic centres, as per terms and conditions of the agreement.
