Minutes of the Meeting

A meeting of the Advisory Committee for Bio-medical Waste Management was held on 6th February 2018 at 4.00 pm under the Chairmanship of Pr. Secretary, Health & Family Welfare Department in his chamber, Delhi Secretariat, New Delhi-110 002, to discuss the issues relating to biomedical waste management in Delhi. List of participants is annexed.

After a round of introduction by the members and invitees, the meeting commenced with welcome address by the Chairperson. A brief overview on Biomedical Waste Management Rules 2016 and the decision taken in the previous Advisory Committee meeting was given by Addl. Director (BMW Mgmt.).

The following issues were deliberated and decisions taken in the meeting:

S.No.	Issue	Discussion/Decision
1.	Requirement of additional common biomedical waste treatment facility (CBWTF)	<p>Additional Director (BMW Mgmt.) informed to the Chair that regarding requirement of additional Biomedical Waste Facility, a Committee has been constituted under the chairmanship of Member Secretary, DPCC. The report of the Committee was presented before the Advisory Committee (copy enclosed) by Member Secretary, DPCC. After detailed deliberations among all the members, the consensus of the Committee is that two more CBWTF in the NCT of Delhi are required in the light of following points:</p> <ol style="list-style-type: none">1. Delhi is the medical hub where the patient comes from across the country and also from neighboring countries. So number of health care facilities and quantum of biomedical

waste would increase substantially.

2. The facility M/s SMS Water Grace has an agreement with government till 2020. Thereafter only one facility would be left to manage whole biomedical waste of Delhi. In the event of any breakdown or contingency, Delhi would in a very difficult situation to follow BMW Rules.
3. Installation of new CBWTF may take at least two years and the decision has to be made now.
4. Proper zonewise distribution of BMW Management would help in better management of biomedical waste and environment.
5. Less transportation of BMW Waste, less travelling thereby less pollution in Delhi.
6. New CBWTF will be permitted with latest technology (Rotary) thereby it will generate less pollution.
7. More competition better compliance of Biomedical Waste Management Rules by CBWTF.
8. No monopoly and no cartelization.
9. Substantial increase of registration of private clinics as per Biomedical Waste Rules 2016. So more biomedical waste will be produced.




