MINUTES OF MEETING

A meeting was held under the Chairpersonship of Hon'ble Minister of Health, GNCTD on 27.02.2024 at 3.00 PM in his Conference Room regarding (i) Large number of vacancies in Mohalla Clinics which are not being filled since long; (ii) Status of tests in Mohalla Clinics and (iii) Status of medicines in Mohalla Clinics.

At the outset, the Chairperson welcomed all the participants. He informed that it has been brought to his notice that some Mohalla Clinics are non-functional/ closed since October, 2023 onwards.

Hon'ble Minister (Health) enquired regarding reasons why these AAMCs are non-functional, the total number of non-functional AAMCs and the actions taken by the officers concerned for making them functional.

It was informed that non-availability of empanelled doctors is the primary reason for AAMCs remains non-functional. CDMO (North) informed that the existing merit/ waiting list of empanelled doctors of the district has exhausted as a result of which many AAMCs are non-functional. Further, doctors are not appearing for the interview being conducted for empanelment. Addl. CDMO (Central) apprised that all AAMCs in the district are functional. Wherever empanelled doctors are not available, regular/ NRHM doctors are posted in AAMCs.

CDMOs informed that another reason for AAMCs remaining non-functional is the provision of providing 07 working days in the offer letter for joining. In case, the doctor concerned does not join, the next on the merit list is given the offer and is also provided 07 working days to join. This leads to AAMC remaining non-functional.

Secretary (Health) informed that the existing procedure of seeking approval of the merit list of empanelled doctors by him is unnecessary and suggested that CDMOs should empanel / issue offer letters doctors at their own level. Further, in order to maintain transparency, the merit list should be displayed on Delhi Government Website.

Hon'ble Minister (Health) enquired regarding the availability of blood/ lab tests in AAMCs. It was found that blood/lab test facilities are presently available only in four out of eleven districts. CDMOs informed that no clarity has been provided whether these services can be continued even after the expiration of tender.

Secretary (Health) informed that a system has been developed whereby four digit OTP would be generated and sent on the patient's mobile number for verification purpose and blood/lab test facilities in AAMCs would become functional in all districts within a week.

After detailed discussion and deliberations, the following decisions were taken:

1. Walk-in interview for empanelment of doctors for AAMCs shall be on weekly basis as per earlier practice so that merit list does not exhaust.
2. The existing practice of seeking approval of the merit list of empanelled doctors from Secretary (H&FW) shall be done away with. In order to maintain transparency, the merit list of empanelled doctors of each district to be uploaded on Delhi Government Website.
3. The existing practice of empanelment of paramedical staff (Pharmacist/MCA/MTW) at State Level shall continue.
4. The resignation/withdrawal of resignation by empanelled doctor shall be accepted by the CDMO at their own level. Further, CDMO concerned shall ensure that a new doctor from the merit list joins the Mohalla Clinic concerned within 05 days of acceptance of resignation of the previous doctor. Post-facto approval of fresh empanelment/resignation/withdrawal of resignation shall be sought on a monthly basis from Secretary (H&FW).

5. CDMO (North West) to share the existing merit/waiting list of empanelled doctors with CDMO (North). The doctors in the said list of North West District may be offered for empanelment in North District.
6. In order to resolve the issue of accepting the offer of empanelment by doctor and thereafter not joining/reporting to the office of CDMO or assigned AAMC, he/she shall be informed during the interview itself that in case of non-joining he/she shall be debarred from empanelment in any district in future.
7. The existing panel of MTWs to be extended for further six months or till the fresh examination is conducted, whichever is earlier.


The meeting ended with a vote of thanks to the Chair.


