## Office Memorandum

In partial modification of O.M No. DPCC/WMC-1/CBWTF/2014/1481, dated 24.02.2014 and in pursuance of decision taken in the meeting of Advisory Committee for Bio-Medical Waste Management held on 11.05.2015 at 5.00 P.M. under the Chairmanship of Special Secretary (Health & Family Welfare) in the Conference Hall of Secretary (H & FW) at 9<sup>th</sup> Level, Delhi Secretariat, New Delhi-110002 regarding redistribution of area among two Common Bio-Medical Waste Treatment Facilities (CBWTFs) in Delhi, in the event of closure of Synergy Waste Management Pvt. Ltd. on 18.05.2015. The following redistribution is hereby ordered with the approval of Chairman, DPCC to meet the contingency.

- The area distribution among 2 CBWTFs in 11 revenue districts of Delhi for collection, treatment and disposal of Bio-Medical Waste w.e.f. 19.05.2015 shall be as follows:-
- (A) SMS Water Grace BMW Pvt. Ltd. (located in West District); Allocated District: West, South West, Central, East, Shahdara & North East District
- (B) Biotic Waste Solution Pvt, Ltd. (located in North District); Allocated District: North, North West, New Delhi, South, South East District
- The allocation of additional district of above mentioned CBWTFs has been made only as a part of contingency plan. DPCC in consultation & coordination with Directorate of Health Services GNCTD shall explore other possibilities for long term solution for collection, treatment & disposal of Bio-Medical Wastes
- 3. As per their agreements with the Directorate of Health Services, Govt. of NCT of Delhi, M/s SMS Water Grace BMW Pvt. Ltd. & M/s Biotic Waste Solution Pvt. Ltd. shall continue to collect, transport, treat and dispose off the entire Bio-Medical Waste (BMW) free of cost of Delhi Government Health Care Establishments, in their respective districts.
- The rates to be charged by these CBWTFs from the Health Care Establishments (other than Health Care Establishments of GNCTD), of their respective allotted areas shall not exceed the rates prescribed by Directorate of Health Services, GNCTD.
- 5. The area demarcation decided as above will not affect the existing annual agreements signed by Health Care Establishments with any of the two CBWTFs. However, any fresh agreement or renewal or extension of an agreement with any Health Care Establishment is to be done as per areas of jurisdiction assigned as above. This area demarcation will also not affect the existing agreements where the agreements are based on open tenders and the agreements so made shall continue till the validity of original agreement period.
- The CBWTFs shall be responsible for collection, transportation, treatment & disposal of entire
  Bio-Medical Wastes generated in Health Care Establishments of Directorate of Health Services
  GNCTD.
- Apart from above, all other term & conditions of Office Memorandum dated 24:02:2014 shall remain in force.
