## ORDER

Whereas, M/s DCDC Health Services Private Limited, participated in the tender vide GeM Bid No. 2023/B/4240847 dated 24/11/2023 for haemodialysis services in the government hospitals of NCT of Delhi under Pradhan Mantri National Dialysis Programme(PMNDP).

Whereas, as per tender terms & conditions, a performance certificate (In-Original) was required to be submitted by the bidders duly signed by the authorities concerned wherein haemodialysis services are being provided by the bidders. Further, the performance certificate submitted by M/s DCDC Health Services Private Limited, neither has any file no. & dispatch no. nor name of the issuing authority, hence, a letter was sent to DGHS, Uttar Pradesh to verify the authenticity of the said performance certificate.

Whereas, it has been informed by the DGHS, Uttar Pradesh "Neither this performance certificate has been issued to M/s DCDC Health Services Private Limited from Joint Director(Medical Care), Medical & Health Services, Uttar Pradesh, Lucknow nor signed by Joint Director(Medical) and nor such certificates are being issued by Department of Medical Care" (Copy placed at 3/C-4/C).

Whereas, a show cause notice(SCN) was issued by this office vide no. F.64(74)/ DGHS/PMNDP/2022-23/Pt. File-I/8024-8026 dated 20/02/2024, directing the agency to explain the reasons as to why the action should not be taken against them for submitting forged/bogus performance certificate. Though the agency has replied to the above show cause notice, they have not explained satisfactorily the circumstances which led to submission of bogus/forged performance certificate. Further, the explanation submitted by the agency is unsatisfactory and unacceptable.

And, therefore, M/s DCDC Health Services Private Limited and any of its successor is being blacklisted/debarred for a period of Two(02) years from the date of issue of this letter.

This has been issued after prior approval of the DGHS, GNCTD.
