Sub: Suspension of Dr S. C. Gupta (Delhi Medical Council Registration No. 10660) for period of 180 days.

On perusal of Order No. DMC/DC/F.14/Comp.2725/2/2019/dated 27.10.2019 issued by Dr. Girish Tyagi, Secretary, Delhi Medical Council in reference to complaint of Sh. Deepak Joshi c/o Sh. Suresh Chand Tiwari Flat No B-1, First Floor, Propert No. 108/9, Kishangargh, Vasant Kunj, New Delhi-110070 alleging medical negligence on the part of Dr. S. C Gupta, in the treatment administered to complainant's wife Smt. Poonam Joshi at R. P. Memorial Hospital, 496, Main Najafgarh Road, Nangloi, Delhi- 110041. In the said order it was mentioned that

"...... The Council directed that the name of Dr. S. C. Gupta (Delhi Medical Council Registration No. 10660) be removed from the State Medical Register of the Delhi Medical Council for a period of 180 days with a direction that she should undergo 30 hrs of Continuing Medical Education (C. M. E.) on the subject of Level- II Fetal USG Scan' within a period of three months and submit a compliance report to this effect to the Delhi Medical Council.....'.

"...... Order direction the removal of name from the State Medical Register of Delhi Medical Council shall come in to effect after 180 days from the date of the Order'.

The keepers of all registered nursing homes and private hospitals, situated in NCT of Delhi, are hereby directed to not allow him to practice in their nursing home / private hospital. Failure of the same shall be viewed seriously and action, as deemed fit, would be initiated against the defaulter nursing home / hospitals.
